NOTIFICATION

On the recommendation of the Selection Committee and concurrence of Tripura Public Service Commission communicated vide No.F.6(478)-SM/TPSC/2014/633 dated 22.08.2014, the Governor, Tripura is pleased to appoint the following Fishery Officers, TFFS, Grade-I (Group-B-Gazetted) as Superintendent of Fisheries, THFS, Grade-IV(Group-A-Gazetted) in the Pay Scale of Rs.13,575/- --Rs.37,000/- GP-3,700/- PB-4 plus usual allowances as admissible from time to time on regular basis with immediate effect subject to the result of the connected Writ Petition WP(C) 466 of 2010.
